If not confirmed otherwise life Animals, Removal goods, Heavy cargo and Salvage cargo are excluded.

**Excess:**

The excess per each claim is € 1,500.

**Insurance period:**

The insurance contract is valid from 01.01.2022 until 31.12.2022 and will be renewed tacitly for one year, unless cancelled with three-month notice by either party.
